This is to request the inclusion of supplemental specification for the purchase of Disaster Equipment;

1. For the PPE's and related items should comply **NFPA** or **EN** standard
2. For the rope access equipment specifications are:
  - a) Kermantle Static rope -11mm, 1 roll (100mtrs) for 2 rolls
  - b) Carabiners - Steel screwgate
  - c) Full Body Harness minimum requirement: A basic Class III Rescue harness
  - d) Full Body Harness: Quick adjust waist buckles. Padded Waist, Legs, and dorsal D ring for added comfort. Primary rigging points on the front waist and chest. 2-pc shoulder strap adjuster. Adjustable height dorsal D ring, 2-pc leg strap adjusters. Durable gear loops hold needed equipment, with Chest ring assembly.
  - e) Rescue Pulley: Double NFPA ratings at least 50kN
  - f) Ascenders- NFPA rating
  - g) Descenders- NFPA rating

Target delivery of all the items should be 90 days upon approval of the purchase order.
