- The City Government of Navotas, through the 2022 Annual Budget intends to apply the sum of FORTY-ONE MILLION ONE HUNDRED THIRTY-TWO THOUSAND THREE HUNDRED FOUR PESOS (PHP 41,132,304.00) being the ABC to payments under the contract for PROCUREMENT OF GROCERY ITEMS FOR 116TH NAVOTAS DAY (PIN 2021-12-092). Bids received in excess of the ABC shall be automatically rejected at bid opening.
  - The City Government of Navotas now invites bids for the above Procurement Project. Delivery of the Goods is required by 7 CALENDAR DAYS UPON RECEIPT OF PURCHASE ORDER. Bidders should have completed, within Two (2) Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
  - Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
- Prospective Bidders may obtain further information from City Government of Navotas – Bids and Awards Committee and inspect the Bidding Documents at the address given below during Monday to Friday, 8:00 AM to 5:00 PM.
  - A complete set of Bidding Documents may be acquired by interested Bidders on December 17, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (PHP 25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees, in person, by facsimile, or through electronic means.
  - The City Government of Navotas – Bids and Awards Committee will hold a Pre-Bid Conference on December 24, 2021, 9:00 A.M. at the Mayor's Conference Room, Fourth Floor Navotas City Hall Building and/or through video conferencing or webcasting via Zoom, which shall be open to prospective bidders.
  - Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before January 06, 2022, 12:00 noon. Late bids shall not be accepted.
  - All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
  - Bid opening shall be on January 06, 2022, 2:00 PM at the Mayor's Conference Room, Fourth Floor Navotas City Hall Building and/or via Zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
  - All interested bidders should submit, upon request of the Bidding Documents a Letter of Intent, in person, by facsimile, or through electronic means.
  - The City Government of Navotas – Bids and Awards Committee reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
