CITY APPROPRIATION ORDINANCE NO. 2022-66

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE BILLION SIX HUNDRED TWENTY MILLION SEVEN HUNDRED NINETEEN THOUSAND NINE HUNDRED THIRTEEN PESOS (PHP1,620,719,913.00) FROM THE ESTIMATED ANNUAL INCOME OF THE CITY FOR THE FISCAL YEAR 2023, TO BE MADE AVAILABLE FOR THE OPERATION, MAINTENANCE AND CAPITAL OUTLAYS REQUIREMENT OF THE DIFFERENT DEPARTMENTS AND OFFICES IN THE CITY OF NAVOTAS, METRO MANILA FROM JANUARY 1, 2023 TO DECEMBER 31, 2023 AND FOR OTHER PURPOSES.

- WHEREAS, there is a need to provide appropriations for the current operating expenditures and capital outlays requirement of the City of Navotas, Metro Manila for Fiscal Year 2023;
- WHEREAS, the Local Chief Executive, has submitted before the Sangguniang Panlungsod his proposed budget for Fiscal Year 2023 covering the Annual General Fund embodying his administration's budget priorities;
- WHEREAS, the Sangguniang Panlungsod, in the exercise of its power to approved and authorize the appropriation of the necessary funds has conducted a series of budget hearings to evaluate and consider the propriety of the proposed appropriation under the Annual Budget;
- WHEREAS, after conducting the said budget hearings and evaluation of the proposed budget, the Committee on Appropriations has recommended the approval and consideration of the herein appropriation ordinance embodying the budget proposal of the Local Chief Executive.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Navotas, Metro Manila, that:

SECTION 1. Title – This Appropriation Ordinance shall be known as the City Appropriation Ordinance No. 2022-66 or Annual Budget for 2023.

SECTION 2. Appropriation – There is hereby appropriated, as it is hereby appropriated, the sum of One Billion Six Hundred Twenty Million Seven Hundred Nineteen Thousand Nine Hundred Thirteen Pesos (Php1,620,719,913.00) out of the estimated annual income as probable collection to cover various current operating expenditures and capital outlays requirement, as follows:

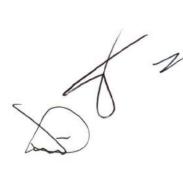

SECTION 3. General and Administrative Provisions -

- PERSONAL SERVICES unless otherwise authorized by law or as may be authorized by higher authorities;
- Changes in the existing organizational structures such as creation, consolidation, splitting, elevation, transfer and abolition of any department, office, section and unit including its functions shall not be made or funded from current appropriation provided for under this Ordinance.
- 2) Organizational unit (s) that may be created by Administrative authorization shall be considered as Ad-Hoc creation that shall be staffed by contractual personnel or staff members on special/additional detail or by temporary and casual personnel as may be authorized by the Sangguniang Panlungsod.
- 3) Authority to fill vacant positions shall be restricted only to those that are necessary for the effective delivery of essential and vital services and priority projects and undertaking; PROVIDED, however, that the necessary appropriations have been provided under this Ordinance; and PROVIDED FURTHER, that such appointment(s) thereat shall be made strictly in accordance with the Rules and Regulations and Laws of the Civil Service Commission.
- 4) The itemization of personnel services in support of the appropriations herein provided under this Ordinance for personal services and together with all existing rules and regulations and applicable memoranda and circulars shall form part of this Ordinance and therefore, shall be subject to its provisions as well as limitations. Furthermore, except as may be otherwise provided by law, the maximum numbers of permanent positions as herein authorized under this Ordinance shall not exceed the numbers of permanent positions needed in the approved Position Allocation List (PAL).
- 5) Contractual Compensation of Consultants, Assistants and other Personnel The appropriations herein provided under this Ordinance shall be authorized only for services of consultants, assistants, experts and other contractual employees rendering specific, essential and vital services which cannot be provided by the regular staff of the office concerned, limited to such period when the services are reasonably and necessarily required and/or to such activities that have a definite period of completion or expected output and results. Furthermore, consultants, assistants and experts herein allowed shall be authorized to receive compensation whose appropriations were provided under this Ordinance at rate (s) as may be authorized by the Sangguniang Panlungsod subject to Civil Service Laws and other related rules and regulations; and PROVIDED FURTHER, that the contractual employment agreement is approved by the Civil Service Commission under the following circumstances;

- 5.a. When the consultant, assistant or expert is an acknowledge authority in his field of specialization; and;
- 5.b. Where the consultant, assistant or expert is hired to perform a specific activity or services that require technical skill and expertise which the present labor force is unable to provide or if such expertise although available, however, is limited.
- B. **PERSONAL BENEFITS** Unless otherwise authorized by the existing law or may be allowed by future enactments, directives and other issuances;
- Authorized Salaries the amount of salaries chargeable against the appropriations herein provided under this Ordinance shall not exceed the rate(s) as approved under existing law pending implementation of RA 6758 otherwise known as the Compensation and Position Classification Act of 1989.
- 2) Non-commutable and transportation allowances granted and chargeable against the appropriations herein provided under this Ordinance shall not exceed the amount so authorized under existing regulations the latest of which is the Joint Commission on Local Government Personnel Administration (JCLGPA) Circular No. 35 dated September 30, 1989; PROVIDED, FURTHER that the transportation allowance herein provided under this Ordinance shall not be allowed to officials who are assigned a government vehicle or who use government motor vehicle in the performance of his official duties and functions.
- 3) Uniform Allowance as allowed and chargeable against appropriations provided under this Ordinance shall not exceed the amount of Six Thousand Pesos (Php6,000.00) each year. Provided, that the uniform allowance shall be released in cash to each employee before the close of the first quarter of the current budget year.
- 4) The amount of honorarium as may be allowed and made chargeable against appropriation provided under this Ordinance may be paid to government officials, whether local or national and local government who are duly assigned or designated by the Local Chief Executive to render services either full time or part time basis to and inter-agency or ad-hoc committees that may be created to perform specific services, projects or programs with appropriations provided under this Ordinance at such rate(s) as may be approved by the Sangguniang Panlungsod;

PROVIDED, that such rate(s) shall not exceed the rate(s) authorized under existing laws, rules and regulations; PROVIDED FURTHER, that no payment of honorarium shall be paid out of the appropriation herein provided under this Ordinance, to person not regularly employed in the City, except resource speakers, experts, consultants or specialists who are acknowledge authorities in their fields of specialization for services to be rendered and at such rate(s) as may be authorized by the Sangguniang Panlungsod in accordance with existing rules and regulations as may be issued by higher authorities from time to time.

- 5) Salary Adjustment of 20% or more as may be directed by the Department of Budget and Management (DBM) chargeable against appropriation provided herein to regular, casual and contractual employees unless otherwise allowed by the Sangguniang Panlungsod, for implementation
- C. MAINTENANCE AND OTHER OPERATING EXPENSES No appropriation herein so provided under this Ordinance shall be utilized for any activity or undertaking that is considered private in nature or character, except as may be expressly authorized by law and other issuances of the higher authorities. Funds as appropriated under this Ordinance for specific programs, projects and activities shall only be released and used solely for their intended purpose(s) for which the same are herein appropriated, except as may be modified and authorized by the Sangguniang Panlungsod through enactment of supplemental budget ordinances.
 - Use, operation and maintenance of motor vehicles and other transport equipment the amount of appropriation herein so provided shall be utilized solely for government owned motor vehicles and other transport equipment and if no case, funds be released to cover the use to such privately owned motor vehicles, except when such vehicles or the use of such motor vehicles are acquired through donations from the private individuals or organizations;

PROVIDED, that the use of such vehicle(s) is to carry out the official functions and activities of the City Government. The use of government vehicles by officials and/or employees of the local government shall be authorized only through the issuance of such trip of a serially numbered trip tickets duly signed by approving officials. The government owned motor vehicles shall be used for official business only and shall bear government plates. Violation of these provisions herein cited shall cause the withdrawals of the privilege to use the motor vehicle.

- 2) Purchase of locally manufactured products. The appropriations herein provided under this Ordinance for the purchase of supplies and materials shall be made available only for locally manufactured products and materials, except when none is available in the market or when the price of locally manufactured articles exceed those item as determined under the Flag Law.
- 3) Limitations of purchase of supplies and materials. The stock of supplies and materials including spare parts acquired, through ordinary purchases out of the appropriations herein provided under this Ordinance shall, at no time exceed the normal three (3) months requirement.
- Seminar Expenses The amount herein provided under this Ordinance for the conduct of seminars, workshop and in-service training courses of local government officials and employees shall only be allowed on those officially sanctioned by government authorities or as may be authorized by existing law
- D. CAPITAL OUTLAYS The appropriations herein provided under this Ordinance for capital outlays or development projects, programs and undertakings shall only be released and used solely for their intended purpose(s) for which the same were appropriated, except as may be otherwise authorized, modified and approved by the Sangguniang Panlungsod through the enactment of supplemental budget ordinances.
 - D.1 All infrastructure and other public work projects appropriated herein under this Ordinances shall only be done or implemented by administration except for special projects which cannot be implemented by our engineer's office and shall be implemented through public bidding. Provided, that all authorized contracts entered into in the name of the City shall be submitted to the Sangguniang Panlungsod for its concurrence/ratification subject to applicable laws and COA rules and regulations.
- E. CALAMITY FUND The appropriation herein provided under this Ordinance for Calamity Fund shall be disbursed for emergency expenditures such as relief and rescue, repair and other rehabilitation activities in times of natural calamities, "force majure" or unforeseen events and for prevention/alleviation of flooding and other disaster preparedness and prevention program and equal to 5% of the estimated Fiscal Year revenue from regular service.

SECTION 4. Authorization of Contracts. The City may enter into a contract of whatever nature involving the expenditure of public funds including among others, contract of lease, contract to construct buildings and roads and public works projects, contract of lease and rental of equipment, construction of partitions and improvement of leased buildings and premises or contracts involving an increase in the approved contract price and contract of service of consultancy to be funded from the appropriations herein provided under this Ordinance and the Local Chief Executive is authorized to enter into any contract.

SECTION 5. Enactment of Supplemental Budget - Change or changes in the annual budget herein authorized under this Ordinance may be made within the calendar year by way of supplemental budget per year as provided under RA 7160, PROVIDED, that such supplemental budgets shall pertain to new projects or activities not otherwise included in the approved appropriation herein provided under this Ordinance. Additional supplemental budgets shall be approved only in time or emergency or during exceptionally urgent needs of the City.

SECTION 6. Authority to Adjust Appropriations - no ordinance shall be passed authorizing any transfer of appropriations from one time to another, however, the City Mayor and the Presiding Officer of the Sangguniang Panlungsod are authorized to augment, realign and reclassify any item in the approved annual budgets for their respective offices from savings in other items within the same expense classification of their respective appropriations to the amount of not more than P300,000.00 even without prior approval of the Sangguniang Panlungsod but report of the same shall be made to the Sanggunian within 30 days from the date of augmentation, realignment or reclassification.

SECTION 7. Repealing Clause - All local ordinances, resolutions, rules and regulations or any part thereof inconsistent with this Ordinance are hereby repealed or deemed modified accordingly.

SECTION 8. Effectivity - This ordinance shall take effect on January 1, 2023 except when otherwise provided.
