Local School Board Resolution No. 2022-03

**A RESOLUTION APPROVING THE UTILIZATION OF A PORTION OF THE FY 2022
APPROPRIATIONS FOR SPORTS DEVELOPMENT ACTIVITIES FOR THE
2022 NATIONAL INVITATIONAL SPORTS COMPETITION (NISC) IN ILOILO CITY**

- WHEREAS,** the Philippines, through the Department of Education (DepEd), in coordination with the local governments of Dumaguete City and the Province of Negros Oriental, and DepEd Region VII, will host the 12th ASEAN Schools Games (ASG) on November 19 to 28, 2022 in Dumaguete City;
- WHEREAS,** in connection to the Philippines' participation in the said international school sports competition, DepEd shall spearhead the conduct of a National Invitational Sports Competition (NISC) for the seven (7) sports events to be played in the ASG, namely Athletics, Badminton, Basketball, Sepaktakraw, Swimming, Table Tennis, and Volleyball;
- WHEREAS,** the NISC shall serve as an alternative avenue in the efficient and effective identification and selection of student-athletes in the absence of an organized school sports tournaments or competitions such as the Palarong Pambansa due to the COVID-19 pandemic;
- WHEREAS,** delegates from Navotas City have been selected to participate in the said competition, particularly for the Athletics Meet on May 29-31, 2022 in Iloilo City;
- WHEREAS,** Sports Development is one of the components of the allocation of the Special Education Fund, as stipulated in DepEd-DBM-DILG Joint Circular No. 1, s. 2017;
- WHEREAS,** there is an approved appropriation amounting to PHP 200,000.00 for the conduct of the Division Palaro in the annual Special Education Fund for FY 2022;
- WHEREAS,** the Local School Board has amended its Annual Investment Program to include the participation to the NISC;
- WHEREAS,** the Board, after a thorough discussion on the matters discussed, has moved to utilize a portion of the appropriations for Sports Development to cover the various expenses of the Navotas delegation to the NISC, to wit:



Local School Board Resolution No. 2022-04

**A RESOLUTION APPROVING THE UTILIZATION OF THE CONTINUING
APPROPRIATIONS – CAPITAL OUTLAY (ACQUISITION OF SCHOOL SITE – LAND)
FOR BANGKULASI SENIOR HIGH SCHOOL**

- WHEREAS,** Section 1, Article XIV of the Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";
- WHEREAS,** under Republic Act (RA) No. 7160 or the Local Government Code of 1991, the Special Education Fund (SEF) provides the source of funds for the supplementary annual budgetary needs for the operation and maintenance of public schools within the province, city or municipality through an annual SEF Budget and that the formulation, approval, and utilization of the SEF Budget are the responsibility of the individual Local School Board in each province, city, or municipality;
- WHEREAS,** DepEd-DBM-DILG Joint Circular No. 3, s. 2017 allows the charging of expenses against the SEF for the construction and repair of school buildings, including the acquisition and titling of school sites;
- WHEREAS,** the Angeles National High School (formerly Bangkulasi National High School) and Bangkulasi Senior High School have been sharing one (1) building since S.Y. 2017-2018;
- WHEREAS,** Mr. Carlos M. Oro, school principal, has expressed concern regarding the capacity of the school facility to accommodate the increasing enrollment of both schools through the years;
- WHEREAS,** Bangkulasi Senior High School has requested funding for the acquisition of a parcel of land in order to put up a separate school facility, a major requirement for the approval of the establishment of Senior High School by DepEd National Capital Region;
- WHEREAS,** the Commission on Audit (COA) issued Audit Observation Memorandum (AOM) No. 2022-001-SEF dated February 22, 2022, citing unutilized Continuing Appropriations - Capital Outlay, including the Acquisition of School Site - Land, amounting to **FIVE MILLION PESOS (PHP 5,000,000.00)**;
- WHEREAS,** the COA has recommended implementing or realigning the said unutilized appropriations;
- WHEREAS,** this Board, after a thorough discussion and evaluation of the matters discussed, has moved to utilize the said funds for the purchase of a parcel of land for Bangkulasi Senior High School;





