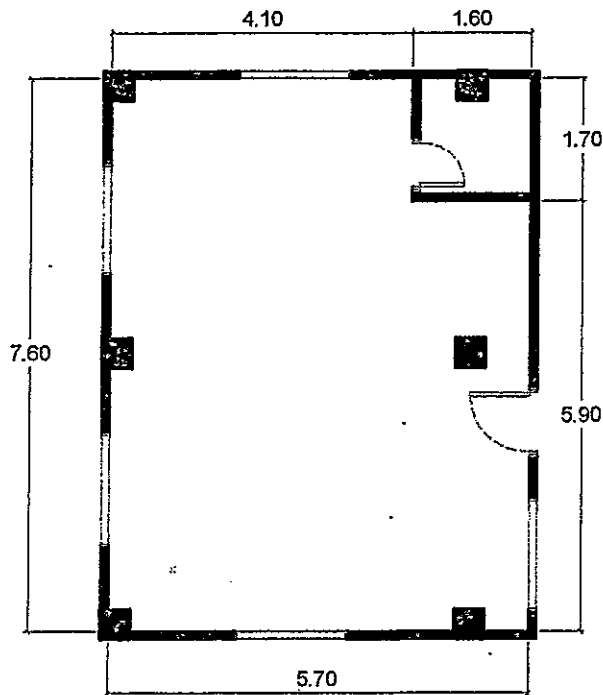

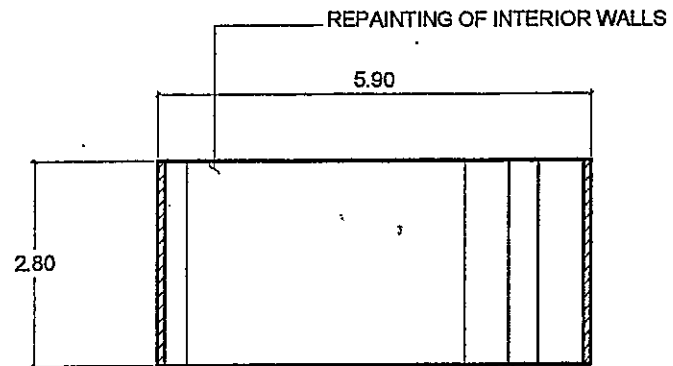

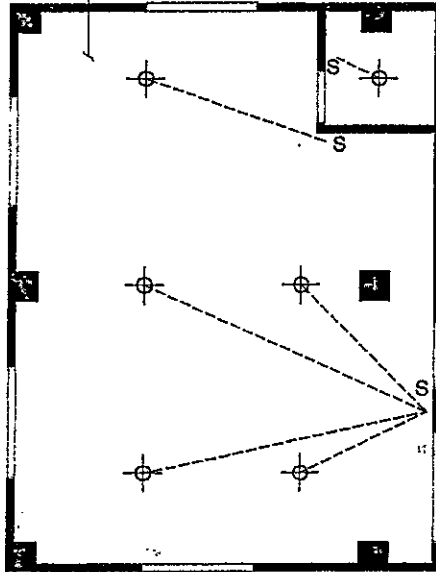

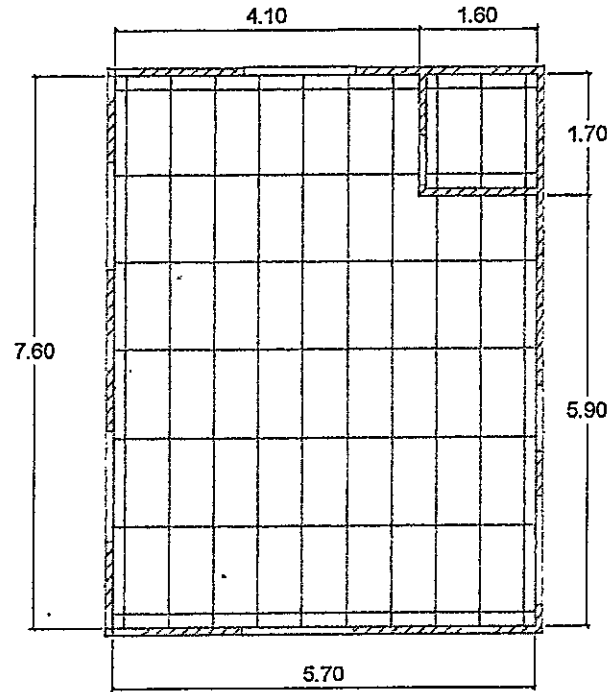
INSTALLATION OF NEW CEILING

- CARRYING CHANNEL @ EVERY 0.60 M. O.C., BOTHWAYS

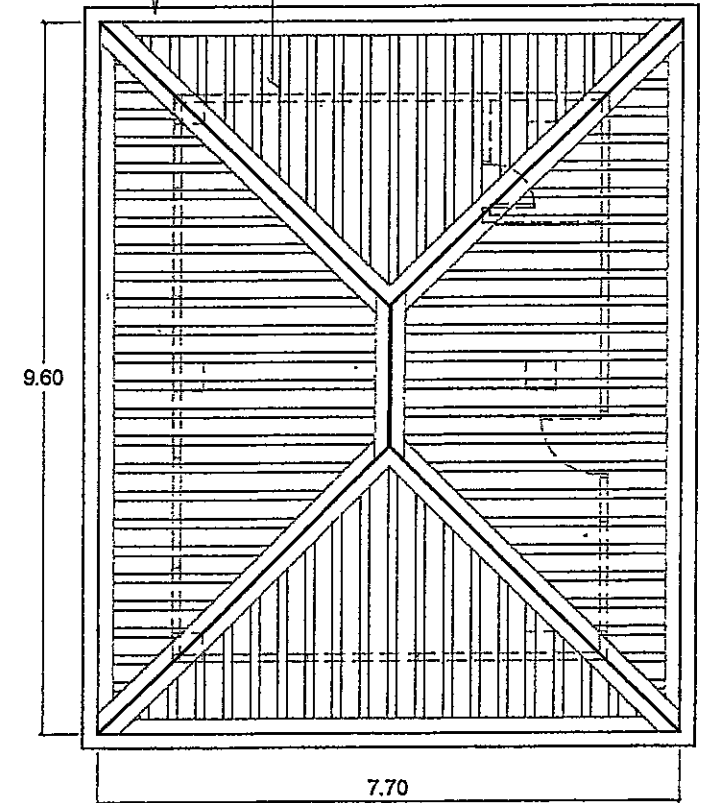


CEILING METAL FRAMING PLAN
