## A RESOLUTION APPROVING THE APPROPRIATION OF THE SPECIAL EDUCATION FUND SAVINGS (SUPPLEMENTAL BUDGET NO. 3)

- WHEREAS. Section 1. Article XIV of the Constitution provides that "The State Shall Protect and promote the rights of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";
- WHEREAS, under Republic Act (RA) No. 7160 (Local Government Code of 1991), the Special Education Fund (SEF) provides the source of funds for the the supplementary annual budgetary needs for the operation and maintenance of public schools within the province, city, or municipality through an annual SEF Budget and that the formulation, approval, and utilization of the SEF Budget are the responsibility of the individual LSB in each province, city or municipality;
- WHEREAS, DepEd-DBM-DILG Joint Circular No. 1, s. 2017 allows the following expenses chargeable against SEF in the operation and maintenance of public schools: payment of compensation/allowances of teachers locally hired in elementary and secondary schools Identified to have shortages per the teacher deployment analysis of Deped, construction and repair of school building, facilities and equipment, educational research, purchase of books and periodicals, and sports development;
- WHEREAS, the appropriation intended for the year-end bonus of the local government personnel under the Special Education Fund will not be sufficient considering the granting of the First Tranche salary increase (LBC No. 121);
- WHEREAS, the Tanza Elementary School building incurred damages in the recent typhoon Ulysses and requires immediate repair;
- WHEREAS, the Acting City Treasurer has certified the availability of 2020 cash balance amounting to ONE MILLION ONE HUNDRED FIFTY THOUSAND EIGHT HUNDRED FOURTEEN PESOS AND 94/100 (Php 1,150,814.94);
