A RESOLUTION APPROVING THE APPROPRIATION OF THE SPECIAL EDUCATION FUND SAVINGS (SUPPLEMENTAL BUDGET NO. 1)

- WHEREAS, the Local School Board prioritizes the continuous improvement of school buildings and facilities to provide learners with a safe and conducive learning environment;
- WHEREAS, as per Joint Circular No. 1, s. 2017 or the Revised Guidelines on the Use of the Special Education Fund issued by the Department of Education (DepEd), Department of Budget and Management (DBM), and the Department of the Interior and Local Government (DILG), the SEF may be allocated to fund expenses pertaining to school operations including utilities expense and maintenance of school buildings and facilities, acquisition of equipment, and sports development activities;
