Description

The Barangay Government of Daanghari, through the Annual Budget 2021 duly approved by the Sangguniang Panlungsod intends to apply the sum of One Hundred Two Thousand Five Hundred Sixty Two Pesos and Fifty Six Centavos Only (P 102,562.56) being the Approved Budget for the Contract (ABC) to payment for the Procurement of PVC ID Printer of Barangay Daanghari, Navotas City. Bids in excess of the ABC shall be automatically rejected at the bid opening.

The Barangay Government of Daanghari, Bids and Awards Committee now invites bids for the Procurement of PVC ID Printer of Barangay Daanghari, Navotas City.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/ fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested Bidders may obtain further information from Barangay Government of Daanghari - Bids and Awards Committee and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m to 5:00 p.m.

All interested bidders should submit (a) Letter of Intent (b) PhilGEPS Reg. Certificate (c) DTI/ SEC Reg. Certificate (d) Business Permit (e) Tax Clearance and other mandatory requirements as provided under Rep. Act 9184.

All bids must be submitted on or before May 18, 2021 at 5:00 p.m.

All bids must be accompanied by a bid security in any acceptable forms stated in the BDS.

Bid Opening shall be on May 19, 2021 – 9:30 a.m at the Barangay Hall, Daanghari, Navotas City. Bids will be opened in the presence of Bidder's Representative who chooses to attend. Late bids shall not be accepted.

The Barangay Government of Daanghari - Bids and Awards Committee reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to award, without thereby incurring any liability to the affected bidder or bidders.
