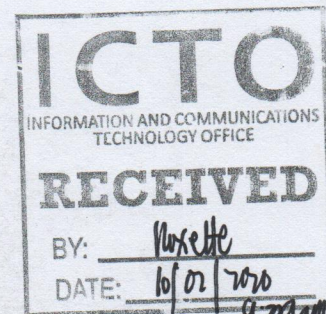

Local School Board Resolution No. 2020-05

A RESOLUTION APPROVING THE APPROPRIATION OF THE SPECIAL EDUCATION FUND SAVINGS (SUPPLEMENTAL BUDGET NO. 2)

WHEREAS, Section 1, Article XIV of the Constitution provides that "The State Shall Protect and promote the rights of of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, under Republic Act (RA) No. 7160 (Local Government Code of 1991), the Special Education Fund (SEF) provides the source of funds for the the supplementary annual budgetary needs for the operation and maintenance of public schools within the province, city, or municipality through an annual SEF Budget and that the formulation, approval, and utilization of the SEF Budget are the responsibility of the individual LSB in each province, city or municipality;

WHEREAS, per DepEd-DBM-DILG Joint Circular No. 1, s. 2017, or the Revised Guidelines on the use fo the Special Education Fund, the SEF may be allocated to fund expenses pertaining to operation and maintenance of public schools, construction and repair of school buidings, facilities and equipment, education research, purchase of books and periodicals, sports development and funding for the ECCD Program;

WHEREAS, the Department of Education has adopted the Basic Education Learning Continuity Plan (BE-LCP) for S.Y. 2020-2021 in order to deliver quality basic education amidst the COVID-19 pandemic;

WHEREAS, under the BE-LCP, schools shall implement blended distance learning modalities most appropriate in their contexts;

WHEREAS, the SDO Navotas City intends to transition from reproducing printed modules to creating digital learning materials in its implementation of the blended distance learning approach for S.Y. 2020-2021;

WHEREAS, the SDO Navotas City has proposed the procurement of USB-OTG flash drives which will contain the digital learning resources and shall be distributed to all public school learners, teachers and school heads, education supervisors, specialists and project development officers;

WHEREAS, this Board, after a thorough discussion and evaluation on the matters discussed, has moved to approve the following appropriations to finance the implementation of the SDO Navotas Learning Continuity Program, specifically its transition from print to digital:
