Local School Board Resolution No. 2023-18

A RESOLUTION APPROVING THE ANNUAL BUDGET FOR PRIORITY EDUCATION PROJECTS OF THE CITY SCHOOL BOARD FOR FY 2024

- WHEREAS, Section 1, Article XIV of the Constitution provides that "The State Shall Protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";
- WHEREAS, under Republic Act (RA) No. 7160 (Local Government Code of 1991), the Special Education Fund (SEF) provides the source of funds for the supplementary annual budgetary needs for the operation and maintenance of public schools within the province, city, or municipality through an annual SEF Budget and that the formulation, approval, and utilization of the SEF Budget are the responsibility of the individual LSB in each province, city or municipality;
- WHEREAS, DepEd-DBM-DILG Joint Circular No. 1, s. 2017 allows the following expenses chargeable against SEF: operation and maintenance of public schools, construction and repair of school buildings, facilities and equipment, educational research, purchase of books and periodicals, and sports development;
- whereas, as per report of the City Treasurer of the City Government, the estimated amount of PHP 127,000,000.00 will be collected from the additional Real Property Taxes which will be accrued to the Special Education Fund (SEF) for FY 2024;
- whereas, this Board, after a thorough discussion and evaluation of the recommendations submitted by the school and division officials and other stakeholders, has decided to appropriate the additional 1% Realty Tax accruing to the SEF amounting to PHP 127,000,000.00 in the following expenditure items:
