

Bids must be submitted to the address below on or before 12:00 noon on September 13, 2024.

All bids must be accompanied by a bond equivalent to ten percent (10%) of the bidder's total amount.

Bids opening shall be at 2:00 PM of September 13, 2024, at the Mayor's Conference Room, 4th floor, Navotas City Hall, M. Naval St., Sipac-Almacen, Navotas City. Bids will be opened in the presence of the Bidder's representatives who chose to attend the proceeding. Bids received lower than that of the total appraised value shall be automatically disqualified at bid opening. Late submission of bid will not be accepted.

Bidding will be conducted through open competitive bidding.

The City Government of Navotas reserves the right to accept or reject all bids, to annul the bidding process, and to reject all bids at any time before contract award, without thereby incurring liability to the affected bidder or bidders.
